Dear Majority Leader Monning, Minority Leader Bates, Speaker Rendon and Minority Leader Dahle:

The Telecommunications Industry Association (TIA) opposes the adoption of SB 822 currently pending in the California legislature. As the trade association representing the interests of the information and communication technology industry, TIA supports efforts at the federal level to address net neutrality in a bipartisan fashion, rather than through a patchwork of state laws.

Debate over net neutrality has never been about whether to have an open internet, but rather what regulatory regime can best achieve internet openness while also maintaining the incentives for investment that have made this country's broadband networks the envy of the world.

The right way to ensure a free and open internet, and to support the continued growth of our nation's broadband infrastructure, is for the U.S. Congress to pass genuine bipartisan legislation. National permanent rules would not only remove the uncertainty hanging over consumers, broadband providers, and manufacturers, but also boost new investments, make our networks even faster and more efficient, and help close the digital divide.

TIA's member companies provide the technology necessary to build the networks over which data travels and the devices on which consumers and businesses rely to access and use that information. As such, we strongly support an open internet that enables the free flow of information and commerce that drives our economy. We support policies that encourage innovation and investment in infrastructure and high-tech equipment and that create high-paying manufacturing jobs.
